Charity One-Ball.

The Bears are entering this national fund raising event and our heat to find the Bear's representative is to be held on **Sunday 15th April**, starting at 10.00a.m. Five people have already signed up and we need at least another five. Entry is £5 per person and all money goes to Breakthrough, the cancer charity.

The competition is fast, fun and will be a good way to blow away the cobwebs after the winter hibernation. Please let Don know if you would like to join us.

What is One-Ball?

National organiser, Kevin Carter, sent the following information:

One-ball is Association croquet, with roquets and croquets, but with only one ball each. So, breaks are far more difficult to come by and if you can put together a break with bisques and get through four or five hoops then that is often a match-winner. The rules are exactly the same as for the full game, with two balls each - each ball has to negotiate twelve hoops and the winner is the first to peg-out. Note that wiring lifts are more common in one-ball.

However, many play it rather like golf croquet - getting in front of your hoop, next turn running it, then going to the next.

As for bisques, the higher handicapped player gets one third of the difference, rounded to the

nearest half. For instance, a 10 playing a 5 would get $(10-5)/3=1.5$.

A-class players play with a reduced handicap - see Appendix 6 in the Laws.

A game will typically last about 25-30 minutes and you can quadruple bank.

The majority of heats are played over half a day - i.e. about six rounds - and the swiss format is ideal, though blocks or a knock-out would work, too.

The winner gets a free place in the final, at Winchester, on **12th May**. If your winner cannot make it then send the 2nd or 3rd instead.

Laws challenge. What should be done here?

Michael Poole sent in this question:
Red was in front of its hoop at the beginning of a stroke. Blue was beyond the hoop about 4.5" straight ahead. In the stroke Red went through the hoop, roqueted Blue, but because of ground conditions bounced back into the jaws. Was the hoop point scored?

(The person playing Red thought Yes, the person playing Blue thought No.)

Laws challenge *Official answer:*

Law 14c states:

"...a ball completes running the hoop when it clears the plane of the playing side while travelling forward through the hoop, **providing that it comes to rest on the non-playing side clear of that plane.**"

Additionally, there are "Official Rulings" published to support the Laws Book. In it, the following is written:

"14.2 Ball falling back.

A depression or "Rabbit Run" can sometimes develop in the ground between the uprights of a hoop, so that a ball clears the playing side, or even the jaws, but then falls back so that it ends the stroke in a position where it is protruding from the playing side. If so, it has not run the hoop. This is the case even if it hits a ball that was some distance behind the hoop. If the ball it hit was live, a roquet will have been made but the hoop will not have been scored."

But, if the Ball it hit was "dead" it is end of turn.
