3. Help! What do I do now?

This article is printed on its own page in case you want to cut out and keep it.

At the end of my turn, I carefully laid up both my balls by hoop 4 out of my opponent's way. When my opponent took to the court, he announced "Sorry, I should have put my clip on hoop 4 at the end of my last turn. I forgot."

You have been misled. Had you realised that his clip should have been on hoop 4 you may not have laid up there.

What happens now?

The first part is simple. You are entitled to a replay.

Now the problems begin because where does the replay start? In your turn you may have made some hoops and you would not relish the idea of having to start that turn all over again. Panic not! You do not have to.

The law says you are entitled to a replay from the point where your being misled influenced your decisions. Therefore, you have to unpick your turn to decide at which point you would have done things differently had you not been misled. The balls are then replaced in the positions they were in at that point, any points scored beyond that point are cancelled, any bisques taken beyond that point are restored and you then continue your turn.

If, in reality, you would have done nothing differently, then there is no problem. You agree to do nothing.

Your opponent cannot force you to a replay. The law states you are *entitled* to one.

But what if my opponent had started his turn, or even if it was spotted later in the game and he has made hoops before noticing the clip was misplaced?

The same answer applies. ALL play from the point at which YOU were misled is deemed not to have taken place so his points scored are cancelled, his bisques used are reinstated and the clips placed back where they should have been at the point of misleading. [Law 31]

But before you get too gung ho and think you can manipulate this situation to your advantage (not that you would!) Law 31e states that both players have a duty to ensure clips are correctly placed and must call attention immediately to any misplaced clip.

To end the season on a light note (but still a law), anything you wear or carry on the court is considered a part of your body. So if you are smoking a cigarette or wearing a hat and it falls off and touches a ball, that is a fault under Law 28a13 and your turn ends.

You may like to spend the cold winter nights seeing how far you can push that one! What about the ash from your cigarette? Or a button falling from your shirt?

A beginner's guide to advanced play.

Normal Association rules apply with the following additional rules:

When your ball makes one-back, it triggers *a lift* for your opponent at the start of his turn.

This happens again when your ball makes four-back.

Therefore, it is common to see a player get as far as three-back and end his turn after laying up with a *leave*. The classic leave is with your two balls together near one boundary, one of your opponent's balls at the peg and the other on the opposite boundary. (There are other leaves).

You then hope your opponent lifts one of his balls, plays it from a baulk and misses the roquet – end of his turn.

If your ball makes one-back **and** four-back in the same turn, this triggers a *contact lift* for your opponent. This means that, at the start of his turn, he can lift a ball and place it in contact with any other ball to take croquet.

Once your first ball has made one-back and you have therefore given a lift, your second ball (sometimes called *the backward ball*) triggers lifts as before when making one-back and four-back **but does not** trigger a contact lift if both are made in the same turn.

You can peg out your ball even if your other ball is not a **rover ball**.

Once you have pegged out a ball (either one of your own or of your opponent) you are no longer entitled to a lift when your opponent makes one-back or four-back.

And finally...
